NEW YORK, September 20, 2018 — *Global Finance* has announced its 27th annual ranking of the World's 50 Safest Banks. The full list is included here and will be published in the November issue.

European banks dominate the top ten of the World's Safest Banks again in 2018, taking all ten positions. Germany's KfW is in the top spot for the eighth year in a row, and the top six are unchanged compared to 2017.

Canadian banks came in strong for 2018, with Toronto Dominion Bank and Royal Bank of Canada making big moves to numbers 11 and 12.

Asian banks put in a strong showing in the top 20 once again, led by Singapore's DBS Bank at #14 and followed by OCBC (#15), United Overseas Bank (#17), Korea Development Bank (#18) and Export-Import Bank of Korea (#19).

The full results of this exclusive survey will be published in the November issue of *Global Finance*. The safest banks will be presented awards at a special ceremony to be held during the Annual Meetings of the IMF and World Bank in Bali on October 13 at the Inaya Putri Bali.
